

2008 SENIOR CHAMPS TIME TRIALS
HOSTED BY THE Gulf Coast Swim Team
July 25 and 26, 2008

- SANCTIONED BY:** Florida Swimming sanction (*Friday*)# 4621 (*Saturday*)# 4622
- TYPE OF MEET:** 50 meter Long Course Senior Time Trials. All events will be deck entered and deck seeded. (Swimmers must be entered in the Senior Championship Meet in order to compete.)
- DATE & TIME:** Friday, July 25th and Saturday, July 26, 2008 to start approximately 45 minutes following the end of the prelim session of the championship meet.
- LOCATION:** Lee County/FGCU Aquatic Center, 10501 FGCU Blvd. South, Ft. Myers, Florida 33965
- POOL SPEC:** Certified 50 meter course, outdoor pool with maximum 8 long course racing lanes having a minimum depth of 6' 7" feet and non-turbulent lane 25 yard lanes available for warm-up/swim down.
- TIMING EQUIPMENT:** Daktronics timing system and scoreboard with stopwatches for backup times.
- ELIGIBILITY:** CLOSED - only swimmers entered in the championship meet are eligible to compete.
- SEEDING:** Long Course times or NT will be used for seeding.
- RULES:** Current USA Swimming Technical rules will govern.
- ENTRY LIMIT:** Swimmers limited to a maximum of 3 events swum per day. The combined total of events swum for the meet and time trials cannot exceed 6.
- ENTRY FEES:** \$10.00 per swim to be paid when deck entered.
- ENTRY DEADLINE:** Swimmers must sign up no later than 10:00 AM on the day of the event. Sign up will be at the clerk of course. Each swimmer must supply their own timers (2)
- ENTRY FORMS:** All entries must be submitted on the time trial entry forms. Entry forms must be signed by a USA Swimming registered member. PLEASE PRINT CLEARLY when filling out entry form.
- WARM-UP:** Warm up lanes will be available during regular competition.
