

606.7 DUTIES AND POWERS - The duties and powers of the officers and other Board Members shall be
844 to attend and participate in all meetings of the House of Delegates and the Board of Directors and as

944 .6 Age Group Vice-chairman: The Age Group Vice-chairman shall chair and have general
945 charge of the affairs and property of the Division that develops and conducts the age group
swimming program of FS.

1110 607.1 DIVISIONAL ORGANIZATION AND JURISDICTIONS, STANDING COMMITTEES AND
1111 COORDINATORS - The divisions of FS shall each be chaired by a Vice-chairman, whose respective
1112 powers, duties, jurisdiction and responsibilities are described in Section 607.2.2. Under each division
1113 Vice-chairman there are officers, committees, coordinators and direct responsibilities as follows:

1330 607.5 DUTIES AND POWERS OF CHAIRMEN, COORDINATORS GENERALLY - The duties and
1331 powers of the General Chairman, the division vice-chairmen, committees or subcommittees (in
1332 addition to those provided elsewhere in these Bylaws) and, when applicable, coordinators shall be as
1333 follows:

1334 .1 Preside at all meetings of the respective division, committee or subcommittee;
1335
1336 .2 See that all duties and responsibilities of the coordinator or the respective division, committee
1337 or sub-committee in his charge are properly and promptly carried out;
1338
1339 .3 Appoint such committees or sub-committees as may be necessary to fulfill the duties and
1340 responsibilities of the coordinator or division or committee, respectively;
1341
1342 .4 Communicate with the respective division, coordinator, committee or subcommittee members
1343 to keep them fully informed;

1345 .5 Keep the General Chairman, the respective division vice-chairman or committee chairman and
1346 the staff of FS's office informed of the respective coordinator, division, committee or
1347 subcommittee actions and recommendations;

1349 .6 Appoint a member as secretary of the committee or subcommittee charged with taking
1350 minutes of each meeting and forward reports or minutes of all meetings to FS's office;

1352 .7 Refer to the Board of Directors any recommendation for action which would establish or
1353 change policies or programs for FS, except as otherwise provided in these Bylaws or by
1354 the Board of Directors; and

1356 .8 Perform the other specific duties listed in FS's Policies and Procedures Manual or as may be
1357 delegated by the General Chairman, the respective division vice-chairman or committee
1358 chairman, the Board of Directors or the House of Delegates.

1360 607.6 DUTIES AND POWERS OF COMMITTEES AND COORDINATORS GENERALLY - Except as
1361 otherwise provided in these Bylaws, the duties and powers of the standing committees and
1362 coordinators shall be prescribed by FS's Policies and Procedures Manual, the House of Delegates, the
1363 Board of Directors, the General Chairman or the respective division vice-chairman. Except as
1364 otherwise provided in the Bylaws, the duties and powers of any other committees and subcommittees
1365 shall be prescribed by FS's Policies and Procedures Manual, the House of Delegates, the Board of
1366 Directors or the officer, coordinator or chairman pursuant to whose powers such committee or
1367 subcommittee was created.
