### HIGH SCHOOL OFFICIATING - MARK YOUR CALENDAR

Registration for officials interested in participating in the 2011 FHSAA Swimming & Diving season will be opening THIS TUESDAY, July 5, 2011 and staying open until August 5th. There will also be late registration available (for an additional \$10 late fee) from August 6th - September 20th. The online rules presentation will take place from July 28 to August 12. The CLOSED book online rules exams for swimming will be available from September 1-12, 2011. Please do not take the

Open Book exam, as it doesn't count towards your high school officiating certification. It is only a courtesy test to help you familiarize yourself with the high school rules.

Also, please remember, all officials interested in officiating at the State Finals meet, or serving as meet referee for District or Region meets will be required to register, watch the online rules video presentation, and take the CLOSED BOOK online test.
