# 2012...It's Recertification Time Again!!

As noted in our Officials' Policies and Procedures, we must recertify in each even year. In order to be recertified for 2013, any official certified prior to May 2012 must: 1) Attend a recertification clinic. 2) Complete the certification – Stroke & Turn/Timer exam (not the recertification exam) with a score of 80% or better, and 3) if necessary, complete the Level 2 Background Check and/or Athlete Protection Training. Also, officials will need to have worked at least 6 sessions in each year.

Recertification clinics will take place at our LSC Summer Championship Series events on the following dates:

# FLAG's (Gainesville, FL): Saturday, July 21, at the conclusion of the morning session

#### Senior Championships (Sarasota, FL): Saturday, July 28, at the conclusion of the morning session

Area Reps will be offering a <u>limited</u> number of recertification clinics in the fall to those who cannot attend either meet, but it is strongly encouraged to attend the sessions either in Gainesville or Sarasota! The sessions are always lively, and it is a great sharing of information! If anyone has a situation that they would like to share, please send it to me.

Senior Championships will offer N3 certification for those officials interested in pursuing that certification level.
